\$450.00 PAID IN FULL BY MAY 2ND (TOTAL REGISTRATION DUES PER PLAYER)

APPLIES TOWARDS THE LEAGUE PLAY AND TRAINING IN THE MONTH OF MARCH; 2 TOURNAMENTS IN MONTH OF APRIL, (1) TOURNAMENT IN THE MAY, (1) TOURNAMENT IN JUNE, AND 3 TOURNAMENTS IN JULY. IF YOU PAY IN FULL UPFRONT AND QUIT AFTER ONE WEEK YOU WILL RECEIVE 75% BACK, AFTER TWO-THREE WEEKS, 50%. IF YOU QUIT AFTER 3 WEEKS YOU WILL NOT RECEIVE ANY MONEY BACK. TEAM PLAYERS RULES

A. PREGAME:

1. Players must be on time for warm up prior to games or player will not start or play based on length of time tardy
2. Players must be dressed in uniform code
 - A. Sweat outfit or top or bottom and team t-shirt and jeans
 - B. No sagging or clothes without team colors
3. Players will carry their own team bags. Parents are not allowed to carry it for them.
4. Go to the bathroom BEFORE the game starts.
5. Bags must be behind bench; all drinks must be with player before game starts.
6. Put your name and/or number on your uniform and bags

B. DURING THE GAME:

1. Players are not allowed to talk to parents, friends or scouts during the game. Parents may not under any circumstance talk to players, coaches or referees unless there is an injury to their child.
2. No player is to question an official's call. Please leave that to the coaching staff.
3. No jewelry, wrist bands, or hats allowed at practices or games.
4. All players will support each other regardless of who is in the game that day. (Everyone WILL play the first half)
5. There will be no bad sportsmanship allowed on this team. No swearing, yelling or arguing at other team, teammates or coaches

C. POST GAME:

1. Uniforms stay on until exiting the gym or player can change in a locker room or restroom; game shoes should be taken off after game either with alternate shoes or sandals;
2. **No parent shall come to the bench for any reason; if parent comes out of aggression, player shall be released from team.**
3. Do not leave the court right after the game; make sure you have all your equipment and met with the coach.
4. Make sure you as the player conduct yourself well before, during and after the game. Use your best judgment.
5. There will always be a post-game team meeting with the coach for next game time, practice, and other game situations.

THE GOAL OF THE INFINITE ABILITY ORGANIZATION IS TO HAVE THE REPUTATION OF A POSITIVE, WELL-MANNERED AND RESPECTABLE ORGANIZATION. IT IS OF UTMOST IMPORTANCE TO SHOW PROFESSIONALISM AND TEAM UNITY. IN ORDER TO ACHIEVE THIS GOAL THE FOLLOWING GUIDELINES HAVE BEEN DRAWN UP FOR PLAYERS, COACHES AND PARENTS. IF ANY OF THESE RULES ARE VIOLATED, PLAYER WILL BE RELEASED IMMEDIATELY.
